Ruth's Driving Academy, LLC shall furnish:

- A licensed and qualified instructor, a car equipped with dual brake control, in safe condition and fully insured, and a classroom equipped with necessary items for the instruction of Driver Education.
- Classroom instruction shall be provided at 1652 Eagle Way, Ashland, OH 44805

Ruth's Driving Academy, LLC shall furnish the following training based on the Ohio Driver Training Curriculum.

- 24 hours of classroom training, utilizing textbooks, videos, discussion and other techniques as shall be available
- 8 hours of practical driving and defensive driving techniques on local roadways and areas set up for specialized driver training

Ruth's Driving Academy, LLC shall charge as follows:

- The cost and terms of the complete 32 hour course shall be:

- The use of school owned vehicles to take the State Driver Examination are available for **\$45.00** for exams in **Ontario or Wooster**.
- If a student / parent, guardian cancels a scheduled driving session, without good cause, less than **48 hours** in advance a **\$30.00 fee** shall be assessed. (VALIDATED PERMIT MUST BE IN POSSESSION)
- Students and their parents shall be responsible for damage to the school's property.

Payment Terms:

- **Account must be Paid In Full prior to scheduling behind-the-wheel instruction.**
- **All Payment plans shall be completed in full within 90 days of the start date. After 90 days a \$5.00 per month finance charge may be assessed. Accounts over 90 days are subject to collections if deemed necessary by the school owner.**
- **NO REFUNDS After starting classes.**

Additional Conditions:

- Classroom sessions that are missed must be completed by attending the same session at a later date.
- **The School will offer the complete course within 6 months of the starting date.**

In compliance with Ohio Administrative Code 4501-7-10-14 all training shall be made available to and completed by the student within **six months** unless mitigating circumstances exist and they have been documented with the school by the student / parent.

- The Student agrees that completion of the course does not guarantee the passing of the State Driver's Examination or the issuing of the State Driver's License.
- **Certificates shall only be issued after course completion. They will be available on the Tuesday following the last drive session.**

The parents, guardian, or person having custody, and the student shall be jointly and separately liable to this agreement.

- A student will be dismissed from class for poor classroom conduct, including but not limited to behavior, dress, conduct, misuse of equipment, or other actions deemed inappropriate by the instructor **without refund**.
- A student may also be dismissed due to illegal, threatening or inappropriate behavior by parent or guardian **without refund**.
- The school owner shall review all situations.
